Flora Baisden (b. Jan 27, 1913, d. March 24, 1989) was born at Pilgrim, KY in Martin County to Mary Alice Cassell Baisden and Atlas Baisden. Flora was the eldest of her sisters: Hester Baisden Ward, Jennie Baisden Endicott and Zelmar Argue Ward. Brothers Harry, Ruben and a sister Lou died in infancy.

Atlas was the son of Jenny Evans Baisden and William Baisden. Mary Alice was born to Miranda Hinkle Cassell and David Cassell.

Zephinar Fannin Jr. (b. May 20, 1912, d. June 11, 1999) was born at Peach Orchard, KY in Martin County to Sarah Ellen Moore Fannin Bowen and Zephinar Fannin Sr. Zephinar was the eldest of his siblings: Elsworth, Everette, William Walter, Marie Fannin Maynard, Carmen, died in infancy. Zephinar was also half-brother to Joshua (Dot), John, Roscoe, Joseph and Betsy Fannin James and

Bell Fannin Moore. Dovie, Vadie and Dixie died in infancy. Zephinar Sr. was the son of Mary Davis Fannin and Henry Fannin. Sarah Ellen was born to Lidia James Moore and William Moore.

Flora and Zephina were married at Milo, KY in Martin County by Abraham Haney Oct. 30, 1931. Their 57 year long union was blessed with 10 children: Ilene Fannin Hinkle (b. Oct. 13, 1932), P.C. (Phil) (b. July 11, 1932), Mary Magalen Fannin Sillman (b. Feb. 25, 1937), Robert A. (b. June 25, 1941), Zephinar Jr. (b. April 1, 1944), Paul Douglas (b. Oct. 1, 1946) and Paula Flo Ellen Fannin Sammons (b. Feb. 2, 1955); Bobbie Joe (b. Jan 1, 1936) Christine (b. May 16, 1938) and John Henry (b. Sept. 3, 1939) died in infancy. Flora and Zephinar had 12 grandchildren and four great-grandchildren.

Flora and Zephinar devoted their lives to rearing their children in a Christian home. Together they overcame a number of obstacles: the death of three children and Zephinar's service in the Navy during WWII in the South Pacific, to name a few. They were fine examples of the virtues of Christian love, charity, hard work and

loyalty to family and community. They were members of the Friendship United Baptist Church.
